Competition law compliance reminder

Please note that all CCSD meetings must be compliant with competition law:

- The CCSD Group is committed to competition law compliance. The consequences of non-compliance are grave the organisations and individuals involved can be fined and individuals may even be sent to jail
- All CCSD meetings, formal and informal, must avoid areas that might fall foul of competition law. Examples include discussion of cartel arrangements, fee or price setting, standard conditions or contract negotiations, the exchange of commercially sensitive market information, or the sharing-out of markets.
- These parameters apply to all CCSD members and stakeholders equally, regardless of organisation type (i.e. insurer, provider or other)
- If the chair feels that the meeting is in danger of breaching competition law, they may bring the discussion to an immediate close, terminate the meeting altogether, or ask individual members to leave
- If any participant has similar concerns at any time, they should raise them immediately with the chair, and/or bring them to the attention of any CCSD member

Board review report

Background and introduction

Following a year of new Board ways of working and governance arrangements in 2023, a decision was made to undertake a review of Board activity with the aim to:

- Give all Board members an opportunity to reflect on the current ways of working;
- Understand the impact of recent changes; and
- Articulate areas for development and improvement across CCSD.

A survey was sent to all Board members in December 2023 and was followed up by 1-2-1 meetings between GT and Board members in January 2024. This information was collated into key themes and supporting recommendations which were shared with the Board in a full detailed report in February 2024. This paper summarises the output of the survey and discussions, and the recommended next steps.

The Board are asked to review and accept the recommendations.

Approach

The table below summarised the approach taken to generate the key themes and recommendations.

Area	Action and purpose
Survey	 Survey sent out via email to all Board members in December 2023 Completion of the survey was anonymous, and 7 Board members completed the survey (70% response rate)

Board review report: key themes

The table below identifies the key themes and a high-level summary of the discussion within that area. Full detail is contained within the supporting pack.

Key theme	Summary
Ways of working at the Board	The Board has made great progress over the last year, but on occasion progress is perceived by some as being hampered by commercial considerations. The Board would value more information/oversight of the BAU and working group activity but were appreciative of the support provided by GT. Board members felt welcome at meetings and valued the role of the independent chair especially in ensuring all voices were heard.
Provider group input	The input of voting provider representatives has helped to progress CCSD's governance and ensure decisions are made for the benefit of the sector, although most recognised there was still more work which could be done. Representation from smaller providers and clinicians is a particular area which needs focus to progress over the next 12 months.
The wider independent healthcare sector	IHPN, PHIN and Healthcode have brought valuable insights into the wider sector. More could be done to utilise these links to communicate with providers and provide insights into code usage.
Working Group	The Board was split around how confident it felt about its understanding of WG activity. Improvements are needed around lines of sight between Board and WG. Given the increase in development activity, a WG refresh is important to ensure work can keep pace with the need of the sector. This review should also consider how technology can support current manual processes.
Potential areas for CCSD development	There are a number of potential areas for development for CCSD, both in the short and long term. GT have drafted a 2024 work plan which is included on the agenda for this meeting. The excellent work done on robotic code development should be communicated to the sector and is an example of CCSD leading the way in a development area.

Work plan for 2024 and potential areas for development

Background and introduction

Following the development of the proportional licence fee model and the agreement of the CCSD budget for 2024 by the CCSD Group, Grant Thornton have developed a proposed workplan for 2024 for agreement by the Board.

This workplan, describes at a high level the business as usual and development activity proposed for 2024. In line with the principles set out in the proportional licence model the BAU activity is supported by the core element of the licence fee, with development activity supported by the variable element which is assessed on an annual basis.

The development elements of the work plan set out some confirmed development activity which is already underway, and additional development activity which is proposed. These proposed development activities include those which were suggested as part of the Board governance review. These activities have all been reviewed and are aligned to the previously agreed CCSD strategy. The CCSD strategy's aims are:

- Drive the development and maintenance of classification system that accurately reflects clinical care delivered in the independent healthcare sector
- Develop Schedule(s) which support reimbursement at an appropriate level
- Be sector led and will work in the interests of all users of the Schedule to help drive transparency of care and funding in the sector
- CCSD will be forward looking and support the move to value-based healthcare
- CCSD will work with other organisations to help drive comparability of private healthcare data with the NHS

In reviewing this work plan the Board are asked to consider if the development activities outlined are the right ones for CCSD to be investing in and if any other developments should be considered.



GT operational/BAU activity

The diagram opposite outlines the core components of GT's operational/BAU activity. This is to inform the Board of the activity which is undertaken to support and deliver the core functions of CCSD. Approximately 60% of the CCSD budget is used to support BAU activities and the running of CCSD and the remaining 40% is used to support strategy and development work.



Development projects

The table below outlines the CCSD development projects. Some of these activities are currently underway with others having been discussed at Board previously or have had a strong steer that they should be undertaken. The final column reflects potential projects which need discussion and prioritisation at Board in order to detail CCSD development work for the remainder of 2024. The projects suggested reflect comments from across the sector and actions which are 'on hold' within the Board action log. Projects in the final column are not confirmed, they are for the Board to consider if further work is desired.

Development projects - potential work

The potential projects outlined on the previous slide are to be discussed in more detail. All of the projects meet the first two of CCSD's prioritisation of development criteria. These two criteria are: Does the proposed work align with and support CCSD to achieve its strategy and does the proposed work enable the sector to move towards having an improved common and complete language set. The Board are asked to consider the suggested next steps for these pieces of work and the appetite to commission work in these areas. The projects suggested as part of the Board review are listed below; the radiotherapy review has been requested by the CCSD Working Group and is detailed on the next page.

Board to discuss and agree priority areas GT to scope out any agreed priority areas and produce detailed project plan and present to Board for approval, before progressing further with development work in these areas It is noted that both the diagnostic test schedule and complexity setting have been discussed at Board previously and there was no clear consensus on these two items.

For complexity setting, it was parked in 2023 and agreed to revisit in 2024 to consider whether there is any change in appetite to be included as part of the 2024 work programme.

For the diagnostic test schedule, CCSD is expending time and resource maintaining and developing the existing diagnostic test schedule although adoption and use by the majority of the sector remains low. A decision is needed on the way forward in order to inform prioritisation of activities and resources.

Development projects - radiotherapy review

Background

- There has been a growing demand for a review of radiotherapy codes, with a number of coding queries and requests pending review. The Working Group (WG) have request Board consider a supporting a deep dive review of these codes.
- Some WG members have volunteered to form a subgroup to review this set of codes, either en masse or ad-hoc. We have engaged with this subgroup to understand the rationale for commencing this review, and its potential scope.

Rationale and current challenges

- These codes are unusual within CCSD and include elements for planning, delivery and supervision sessions. There is also operational guidance on which codes can be used by hospitals and which by consultants.
- Radiotherapy practice has moved on clinically since there was a last comprehensive review of the codes. This work would present the opportunity to Inclusion of codes for new advancements.

- Radiotherapy codes are technically challenging and the Working Group would benefit from supporting clinical and technical expertise in undertaking a full scope review of the codes
- Work on the RAS codes has identified a desire from WG to consider codes as sets and not ad-hoc to ensure that sets are comprehensive and cohesive. Consistency and alignment is needed in wording across codes.


GT recommended next steps

- GT to work up a detailed specification and project plan, including suspected time, for this work to be undertaken
- GT, with Board and WG support, to reach out to potential clinical stakeholders and understand if there is interest in supporting this work
- Board to consider if this work is a priority given the context of other development work proposed

Improving ways of working – main development activity in 2024

Background and introduction

CCSD's ways of working have not been reviewed for a number of years, and there has not been any recent investment in technology supporting ways of working. Both GT and the WG currently spend a lot of time on manual processes that could be automated. In October 2023 the CCSD Board request an additional deep dive into the ways of working within the WG, reflecting additional development activity and a need to update processes. This information has been used, along with that of the Board review and previous engagements to shape a vision for CCSD's future and provide evidence for the new ways of working proposed.



Improving ways of working deep dive - WG January feedback

The diagram below summarised the feedback received from Working Group during the January engagement sessions. This feedback was used along with that from the other engagement sessions outlined in the approach.

Processes

- The processes for the maintenance of the schedule is not congruent with the pace of change.
- The whole process should be connected, automated where possible, and information is should not be duplicated/replicated in multiple sources.
- Unacceptable combinations should be able to be added at the point of a new code request

Technology

- It is currently challenging to keep up with the commentary/voting of WG members on requests.
- Once a form is submitted for a new request, members are unable to make changes or withdraw requests.
- Requests for unacceptable combinations should be unbundled both ways at submission.
- Website search function is challenging and does not always identify the target.

People

- Providers have challenges with adopting schedule changes as insurers are not keeping up with the pace of changes made in bulletins.
- More work to be done communicating changes/updates to help people engage with the website.
- Clinical engagement is needed when new codes are added or codes are changes

Governance

- WG meetings can sometimes include discussions on queries awaiting only a single vote before a decision is made. Members should be encouraged to resolve queries between WG meetings.
- Code requests can be raised that are often revisited in subsequent WG cycles, creating administrative burden for members.

Information

- An improved alignment is needed with OPCS codes
- A regular review of the Schedules is required, perhaps in line with code usage
- Changes to codes can be difficult to follow. For example, links from inactivated to codes to their replacements would be useful.

CCSD project development update - other work

This paper summarises CCSD projects which are not detailed within the other Board papers. The table below provides an update on key areas of work. RAS code development and CAG have their own page to update work in these areas.

Schedule alignment review	•Technical guide is available on the CCSD website. An additional robotic chapter has been drafted, approved and added to the technical guide. •Subchapter review codes have been reviewed by Working Group (WG) and were discussed at the February development call meeting. The agreed changes will be adopted as part of the March code change cycle. The next part of the schedule alignment review, the remaining chapter W, has been prepped by GT and will be shared with the WG for review. •RAS code development is in its final stages of adoption. More detail is contained within the separate update on this.
Training	 Core module is live and is starting to be used by the sector. Engagement is slow currently and would benefit from stakeholders encouraging members to use this resource. The core module is being updated to make the content more interactive; a supplier has been engaged by GT to do this with the first draft of the module expected to be available in mid-March. A RAS bolt-on module has been drafted, reviewed by the Board training team (LD, MR and JS) and is also now live on the CCSD website. Additional bolt on modules will be developed to toe/ankle and gender affirmation codes. These bolt-ons will also be interactive in line with the updated core module.
Provider licence roll out	•Providers are being onboarded by GT with invoices for fees raised from February 2024
Gender affirmation chapter	•A gender affirmation development group was formed who are reviewed all gender affirmation codes, and will presented these as the December WG development call. Codes were then voted on and discussed in the February development call. •Agreed codes will be adopted in the March code change cycle.
Communication and engagement	•First draft of CCSD communication and engagement plan has been written and is going through internal review before being shared with the Board
Other work	•CCSD website updated to reflect current work, the changes to CCSD structures and to enable access to the training materials being developed.

CCSD project development update - CAG and TCSRG

Background and introduction

For the last six months CCSD has been open to applications from CAG and TCSRG. Following the last Board in October, GT provided Board members additional material to circulate within their organisations to encourage applications to the clinical groups.

As it stands there has been one application to CAG, which attached for Board review as a supporting paper. TCSRG applications have also been live since July and there have been no applications received.

Given the lack of applications to these groups the CCSD Board are asked to consider the potential next steps ${}^{\circ}$

Potential next steps:

- Adopt this applicant as a single clinical advisor to Board (in a non voting role) and look to try again at panel in 6-12 months
- Pause CAG in view of lack of application and consider re-scoping later in the year
- · Accept applicant and continue to push for more applications

CCSD project development update - RAS

Background and introduction

In July 2023 the CCSD Board commissioned a review and development piece for robotic codes. This commenced in August 2023 with a detailed approach project plan being developed along with key milestones identified.

Prior to work commencing, ad hoc requests for robotic surgery codes were received into the CCSD Working Group. Evidence showed an increase in requests being submitted to CCSD for new robotic codes, as well as increased usage/activity against existing codes from Healthcode data.

Following the completion of the stakeholder engagement phases, the final proposed RAS code list was developed by GT and presented to Board and the Working Group (WG) in December. It was decided that codes should be adopted in two phases, one in January and one in March.

In January 34 new RAS codes were adopted, with initial unacceptable combinations developed by GT along principles approved by the WG, along with 36 narrative changes. The remaining codes are part of the March adoption cycle.

Summary of project

A high level project plan for the RAS code development project is shown below. Currently the final phase of codes are awaiting adoption in the March code change cycle. The next page details the work which has taken place since the Board extraordinary meeting in December.
